- a) Brandon Hoover- Was present to get an update on no parking ordinance at the end of Fremont.
- 6) Approve Agenda: A motion to approve the agenda of April 24, 2024, agenda made by Mr. Petrini and seconded by Mrs. Morrow. Unanimous voice vote.

7) Approve Minutes:

- a) A motion to approve the minutes from the April 10th, 2024, Council meeting made by Mr. Petrini and seconded by Mr. Bills. Unanimous voice vote.
- 8) Landbank Presentation- Christie Mahany- Came to answer questions that the council had about the landbank and properties in Wesleyville. Mr. Petrini had a question about a property, 2508 Station Rd. How can we find out who owns a property/ locating a owner? Mrs. Mahany said that we can help find someone as the current owner is deceased. The landbank needs to know what properties are flagged by Wesleyville to be able to help. Mrs. Julius asked if the house is to be demolished, could the owners/neighbors next door purchase the lot as just a lot and not build on it? Mrs. Mahany said that would be possible and in Wesleyville's hands. Mr. Johnson brought up the house, 2052 Water Street. Most properties are donated to the Landbank. 2434 Eastern Ave and 3207 Buffalo Road was also brought up in conversation. Mrs. Mahany will look into these 4 properties and get in contact with Marcus.

9) Old Business:

- a) (Tabled) A motion to adopt Ordinance 2024-005 Amending Chapter 21 Streets and Sidewalks, Part 6 Street Cuts, Section 21-607 Cash Deposit or Bond, (1) of the borough's codified ordinances to revise the duration and amount of bonds.
 - i) Adjusted the bond requirements for the street cuts to be \$3,000 rather than only \$1,000 and extended the window for liability to 24 months (about 2 years) rather than only 12 months.
 - ii) Advertised on 04/19/24 can be voted on by Council at the May 8th, 2024, Council Meeting,
- b) (Tabled) A motion to adopt Ordinance 2024 006 amending Chapter 15 Motor Vehicles and Traffic, Part 4 General Parking Regulations of the Borough's Codified Ordinances to add additional locations where parking is prohibited at all times.
 - i) Advertised on 04/19/24 can be voted on by Council at the May 8th, 2024, Council Meeting.
- c) (Tabled) Tabacco Use in Recreation Areas

- a) A motion to purchase 3- 8ft folding tables for the Borough Hall from Sam's Club for a total of \$299 was made by Mr. Wilder and seconded by Mr. Bills. Unanimous voice vote.
- b) A motion to adopt Resolution No. 2024–007, which sets the required Police Pension Contributions in 2020, 2021, 2022 to 0% made by Mrs. Kolesar and seconded by Mr. Wilder. Unanimous voice vote.
 - i) This is necessary as per the Pension Auditor.
- c) TABLED-Approval for the purchase of the Hinkler Park bathroom from _____ for a total of blank.
 - i) Details about what this includes and next steps for the project.
- d) Motion to approve the signing of a support letter for the community garden mural grant made by Mrs. Kolesar and seconded by Mr. Wilder. Unanimous voice vote.
- e) (Tabled) A motion to approve moving the streetlight, located on the alleyway off Eastern Avenue between North Street and Buffalo Road, from Terry Etzel's Penelec account to the Borough's account.
 - i) This service was added by Terry Etzel and has been included under his account since then. The dedicated meter number is 0800254549 0005015647.

ii) This alleyway is not technically Borough-owned property, but it is right by the Borough's North Street parking lot in an area where patrons might walk around the block to Buffalo Road.
